| Students with action | Number of unduplicated students who were assigned an action, regardless of the duration. | |
| Underrepresented | A student group in the action population is represented more than one half of one percent less than their proportion of the school population. | Examples Suspended SWD 11.9%, SWD population 12.5% |
| Overrepresented | A student group in the action population is represented more than one half of one percent more than their proportion of the school population. | Suspended SWD 13.1%, SWD population 12.5% |
| Equal | A student group in the action population is represented is within one half of one percent of their proportion of the school population. | Suspended SWD between 12 and 13%, SWD population 12.5% |
