Definitions

School Enrollment	Number of student's with a current year enrollment in the school at any time during the school year through the report run date.	
Students with action	Number of unduplicated students who were assigned an action, regardless of the duration.	
Underrepresented	A student group in the action population is represented more than one half of one percent less than their proportion of the school population.	Examples Suspended SWD 11.9%, SWD population 12.5%
Overrepresented	A student group in the action population is represented more than one half of one percent more than their proportion of the school population.	Suspended SWD 13.1%, SWD population 12.5%
Equal	A student group in the action population is represented is within one half of one percent of their proportion of the school population.	Suspended SWD between 12 and 13%, SWD population 12.5%

Special Programs Counts

At the School Level	A student is counted in the school total based upon their program enrollment on Jan 7, 2020. this is intended to be representative of the school as a whole, and to avoid using the carryover record from the prior year for FRL data which would inflate the FRL student count for the school.
At the Action Level	A student is counted in program if they were active in the program on the start date of their exclusionary discipline.
