Re-establish the Tax Levy for the Debt Service Fund for 2021 Collection

WHEREAS, Everett School District No. 2, Snohomish County, Washington (the "District"), is a first-class school district duly organized and existing under and by virtue of the Constitution and the laws of the state of Washington; and

WHEREAS, the Board, by Resolution No. 1230, adopted at a regular meeting on May 5, 2020, authorized the District to place a proposition to issue \$317,400,000 in general obligation bonds payable within 20 years from excess ad valorem property tax levies to be placed on the August 4, 2020, election ballot for qualified elector approval;

WHEREAS, the 2021 debt service fund levy anticipated additional principal and interest payments for the September 2020 issuance of Unlimited Tax General Obligation Bonds in the amount of \$50,000,000 if authorized by the qualified electors on the August 4, 2020, election ballot;

WHEREAS, the Board, by Resolution No. 1236, adopted on July 1, 2020, adopted the operation budget for fiscal year 2020-21 certifying for 2021 a Debt Service Fund Levy of \$51,600,000;

WHEREAS, on August 4, 2020, the ballot measure received total approval of 58.78 percent, but failed to reach the required supermajority of 60 percent plus one vote; and

WHEREAS, due to the above, the District recalculated the amount of ad valorem property tax to exclude estimated principal and interest payments from a planned September 2020 bond sale to lower the amount to be placed on the tax rolls for collection in 2021;

NOW, THEREFORE, LET IT BE RESOLVED, the Board of Directors of the District does hereby direct all appropriate officials to reduce the amount of ad valorem real property tax to be collected for the 2021 calendar year for the Debt Service Fund from \$51,600,000 to \$31,000,000.
