#### WHO QUALIFIES?

A child or youth is considered homeless and qualifies for services when lacking a nighttime residence that is fixed, regular, and adequate.

#### This may include the following:

- Sharing housing due to economic hardship, loss of housing or similar reason.
- Living in motels, campgrounds, trailer parks, or similar locations due to lack of alternative, adequate accommodations.
- Transitional housing and emergency shelters.
- Abandoned in hospitals or awaiting foster care placement.
- Cars, train stations, public spaces, parks, abandoned buildings, and other substandard housing.
- Migrant children, runaways, throwaways (children whose parents will not permit them to live at home).
- Unaccompanied youth who are not in the physical custody of a parent or guardian.

If you are the parent or guardian of a school-aged child and are without permanent housing, your child has the right to go to school.

(McKinney-Vento Act, rev. 01/2002)

# ELIGIBLE STUDENTS HAVE RIGHTS

#### Those rights include:

- Staying in the same school even if you move AND receiving transportation to that school, as long as it is in the student's best interest
- Enrolling in school immediately without all of the documents schools usually require
- Receiving free school meals
- Getting help with school supplies and other needs
- Extra support for youth who are on their own
- Help connecting young children with early childhood services

The educational rights and protections of children and youth experiencing homelessness are provided by the McKinney-Vento Homeless Assistance Act. This Federal law provides support and removes barriers to education of homeless children.

## TIPS FOR COMMUNICATING WITH THE SCHOOL

Find out who your student's school

McKinney-Vento Contact is.

Check & update your contact information so the school knows how to contact you.

Email or call to report absences, tell the school if you are having trouble getting your student to classes or if you need help with transportation.

If you are, or have a student currently experiencing homelessness, you are not alone. You can safely seek help through your school district and make sure you are able to learn and keep up with school. We encourage you to visit ideserveaneducation.org to learn about your educational rights and how to safely find help.

## **Housing Resources**

**Dial "2-1-1"**— Explain your situation and they will direct you to appropriate services and support. If you are sleeping in a car, tent, or another place not meant for habitation, or if you are staying in a motel paid for by a charitable organization, ask for the "Coordinated Entry" intake.
