

Family message on COVID quarantine January 13, 2022

Reminder: Two weeks from the date of your second COVID vaccine, or from your Johnson & Johnson vaccine, is considered completing the primary series of recommended vaccine doses.

Good afternoon families.

Last week, both the Department of Health and the Snohomish Health District made changes to the isolation and quarantine protocol for COVID in <u>K-12 settings</u> and Everett Public Schools is adopting the changes immediately.

Modified quarantine for close contact

Quarantine requirements for students, teachers and staff who come into <u>close contact</u> with someone with COVID:

^{*}For household exposures this would be the last day the person with COVID is considered infectious.

Modified isolation for those with COVID

All people with COVID (with or without symptoms) need to isolate for at least 5 days. For all students, teachers and staff who have COVID:

If you fit into this category	Isolation Requirements
Test positive for COVID but never develop symptoms	 Isolation may end 5 full days after a positive test as long as: You have isolated for at least 5 days. Day 0 is the day of the positive COVID test and day 1 is the first full day after the specimen was collected for the positive test. If you continue to have no symptoms. This applies to anyone with COVID, regardless of their vaccination status. If you develop symptoms after testing positive, the 5-day isolation period must start over. Day 0 is now the first day of symptoms. Upon return, you must wear well-fitting mask
	through day 10 and will need to mask for all activities, including recess extracurriculars and athletics (even if tested) except to eat or drink.
Test positive for COVID and have or had symptoms	 Isolation may end 5 full days after symptom onset or positive test as long as: You have isolated for at least 5 days. Day 0 is the day of the positive COVID test or symptom onset and day 1 is the first full day after the specimen was collected for the positive test. You are fever free for 24 hours without the use of fever-reducing medication and other symptoms have improved. Upon return, you must wear well-fitting mask through day 10 and will need to mask for all activities, including recess, extracurriculars and athletics (even if tested) except to eat or drink.

Test positive for COVID and have or had symptoms that are not improving on or after Day 5

If you continue to have a fever or symptoms that are not improving after 5 days of isolation, an antigen test is recommended. If the test result is positive or no test is completed, you must continue to isolate until day 10, returning on day 11. If the test result is negative, you may return to school and you must wear well-fitting mask through day 10 and will need to mask for all activities, including recess, extracurriculars and athletics (even if tested) except to eat or drink.

If your child is identified as a close contact, you will receive a letter with specifics on how and where to provide proof of a negative test. You still have the option as a parent or guardian to keep your child out on a longer quarantine if you prefer.

Test to Stay

Everett Public Schools will be implementing a "Test to Stay" program, which will enable students and staff to get tested in the school buildings. We are currently waiting for the test kits to arrive but anticipate them in the next two weeks. As you know, test kits are in short supply and high demand. We will communicate more about the Test to Stay program shortly. Prior to any child participating in "Test to Stay", a consent form must be completed by their parent or guardian. We are pleased this step will enable staff and students who are healthy to return to the classroom sooner.
