Our Community

Everett Public Schools serves the educational needs of over 20,000 students. As the 14th largest school district in Washington, Everett is in one of the fastest growing areas of the state. Home to Boeing's largest manufacturing site, the county also enjoys a diversified economic base from its deepwater port to its biotechnology corridor. Currently the district is home to four high schools (grades 9-12), five middle schools (grades 6-8) and 18 elementary schools (grades K-5). Students in the district, speaking 97 different languages, bring rich cultural diversity to our community.

Our School

Sequoia High School is a small high school community of approximately 200 students, and offers a personal, family-like learning environment where students and their teacher-colleagues work side-by-side on a first name basis, to the single goal of empowering the individual student with a meaningful education

Sequoia is a school of choice and is built on three major principles: personalizing, performance, and choice. Sequoia is an Alternative Learning Program. Students enroll in a minimum of three classes per term and a maximum of six classes per term.

Curriculum

Students at Sequoia High School earn 6.0 credits per year with a standard course load of three classes per term. The school year is divided into eight terms with six classes offered daily each worth 0.25 credit. Students may enroll in additional courses beyond the standard 3 in order to earn credit more rapidly or retrieve credits. A total of 24 credits are required to receive a Sequoia High School diploma for the class of 2022. Local colleges and universities offer credit options for our students and the Sno-Isle Skills Center is available for students seeking vocational curriculum. Students can access college level courses through Running Start, College in the High School and Advanced Placement classes.



Grading/GPA

- Sequoia's Academic calendar is divided into 8 terms, and grades are awarded at the completion of each term.
- Each class completed with an 80% standard or higher is awarded a 0.25 credit.
- Grades at Sequoia are awarded as
P = Pass 100%-80%
I = Incomplete (not a final grades)
NC= No Credit 0%-79%
- Only courses with letter grades are calculated in the GPA including College in the High School, Running Start, and courses completed in our partner programs.
- SHS does not rank students
- GPA is based on a 4-pt. scale
- SHS does not weight grades.

Impact of Covid-19 Pandemic: In March of 2020, all Everett School District Schools transitioned to fully remote learning. Grading for Spring of 2020 included an increased emphasis on engagement and participation. Schools remained fully remote through April 2021, with some students returning to a hybrid of in-person/remote learning for the remainder of the 2020/2021 school year. Grading requirements and content emphasis returned to a more standard level during this time. All students returned to full in-person learning in the fall of 2021/2022 school year.
