★ REMINDER - Precision Exams

Precision Exams will help meet several district requirements. **All CTE courses should give the 21st Century Skills Exam** (pre and post) this year.

- Graduation pathway requirement (*reported to OSPI*)
- Industry-recognized credential (*tied to CTE funding*)
- CTE/CTE Science common assessment (for additional exams please reference [Precision Exams Alignment REV.xlsx](#))(*district strategic plan*)
- Used for part of the leadership alignment in your courses (*tied to CTE funding*)
- Used to show growth data when setting your TPEP goals

✓ You can also give the 21st Century Skills Exam as a single assessment but you will not be able to show student growth.

Current Precision Exam Data: 338 CTE students out of 4,815 have taken the 21st Century Skills Exam.

CTE Dual Credit FAQs:

1. What is the difference between CTE Dual Credit and College in the High School?
The basic difference is CTE courses are technical/professional in general and non-transferable or limited transfer. When you look at our general transfer degree (DTA) CTE are classified as Applied Elective B, non-transferable electives.

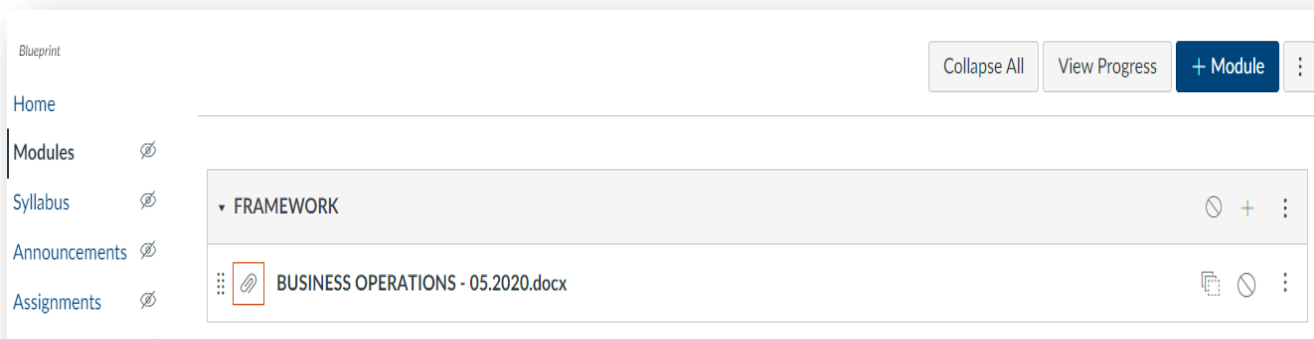
College in the High School courses are academic transferable credits. They apply toward degree requirements in Humanities, Social Science, Natural Science, and Basic Skills.

At least 60 quarter credits must be from courses listed in the four distribution areas: (Basic Skills - 15 minimum; Humanities - 15 minimum, Social Sciences - 15 minimum, and Natural Sciences -15 minimum). No more than 15 credits may be from applied electives (List B). Courses may be applied toward only one distribution area, even if listed as usable in more than one area."
2. If a student has already created a ctcLink account through registering for College in High School, do they need to register again for CTE Dual Credit?
Students do not apply for admission again if they already have a ctcLink account. Students will register in SERS and complete the CTE Dual Credit Transcript Request form CTE Registration Process
