RESOLUTION NO. 1300

Certification of 2024 Excess Property Taxes

A RESOLUTION, certifying to the amount of excess property taxes to be levied in year 2023 and collected in year 2024 for the District's General Fund, and providing for related matters.

WHEREAS, the Board, by Resolution No. 1297, adopted the 2023-24 Operating Budget, that included certified General Fund educational programs and operations excess property taxes in the amount of \$62,071,014 to be levied in 2023 and collected in 2024. The Board has determined that the amount of the District's General Fund school programs and operations excess tax levy previously certified in the 2023-24 Budget should now be increased to \$62,239,149.; and

WHEREAS, the State Legislature has limited the amount local school districts may raise through special levies, and

WHEREAS, the 2024 General Fund Levy cannot exceed limitations imposed by RCW 84.52.0531, and any amount of such excess levy approved by the voters must be reduced in accordance with that statute;

NOW, THEREFORE, BE IT RESOLVED, by the Board of Directors of Everett School District No. 2 pursuant to RCW 84.52.020, that the County legislative authority of Snohomish County, Washington requested to set the 2024 excess tax levy for the General Fund Levy at a total of \$62,239,890, to set the Capital Projects Fund excess levy at \$54,808,000, and to set the Debt Service Fund excess levy at \$4,392,000 as authorized by the voters and approved by the Board of Directors of the Everett School District No. 2 in their meeting on November 28, 2023 and submitted to the County legislative authority of Snohomish County, Washington. The final tax levy may be adjusted for Administrative Refunds of prior year levies as identified by the County legislative authority of Snohomish County, Washington. The County legislative authority of Snohomish County, Washington is authorized and directed, without further Board action to increase the General Fund levy amount to be extended upon the tax rolls and collected in the calendar year to be consistent with the limitations imposed by RCW 84.52.0531.
