- 2. All spring surplus textbook materials should be collected in one area of the school, easily accessible by Maintenance. Let Amritha know the location of the boxes (room #'s) by May 8, 2024, as we need to give Maintenance a list of where the boxes are located in each school.
- 3. Pick-up of the surplus materials will begin on June 24, 2024 (approximately).
