Regarding: **Second Time Sexual Health Curriculum for High School**

[RCW 28A.300.475](#) provides guidance on comprehensive sexual health education (CSHE) to public school students, including that instruction should be provided twice to students in grades 9-12.

- For our high school students, CSHE is provided in Family Health (typically a 9th grade course).
- For the second lesson, we planned to provide a self-paced CSHE course that could be administered within a scheduled advisory (PACK, CHAMPS, OR PAWS) session.
- In the 2023-24 school year only, we had planned to make the self-paced course available to students in grade 12.

Unfortunately, we did not communicate this plan in a timely manner to principals, and therefore were unable to plan for implementation within the remaining weeks of school. Additionally, a Blackboard Connect message went out to students and families prematurely with information about this self-paced course.

On May 21, 2024, at 5:00 pm, a retraction was sent out to students in grade 12, explaining the miscommunication and asking them to disregard the earlier message.

We will develop and communicate the plan for the 2024-25 school year administration of the second session of CSHE for high school students in the fall.
