Transitional Kindergarten is a full school day program and will run through the last day of school, which is currently June 17, 2025.

## EARLY LEARNING OPPORTUNITY

Everett Public Schools is offering **Transitional Kindergarten** for children who **are not** currently in an early learning program and are age eligible to enter Kindergarten in the **fall of 2025**. Students will be screened in November and December 2024 and may qualify based on academic and social-emotional needs.

### To be eligible for screening, children must:

- o **be 5 years** old by **August 31, 2025**
- o live **within** the boundaries of Everett Public Schools
- o **not be** currently enrolled in an early learning program such as: licensed childcare, preschool, co-op preschool, ECEAP, Head Start, etc.
- o **demonstrate** academic and/or social-emotional needs through a screening process
