#### RECOGNITION - 2025 PRODIGIES FOR PEACE COMPETITION WINNERS

Each year, the NAACP, Snohomish County Chapter, holds a celebration honoring Dr. Martin Luther King, Jr., and Black History Month. Students are invited to submit essays and art for the Prodigies for Peace competition as part of the celebration. The Prodigies for Peace Writing and Art Contest helps students draw connections between the people and the events that shaped the civil rights movement and the social issues that influence their lives today.

The essay question asked students to describe what they could do for others that would continue Dr. King's message of equality and justice for all—members of the community judged student work. Students earning first, second, third, and honorable mention awards in each grade band and each creative category were honored for their inspirational works at the community celebration.

This year, Everett Public Schools had 12 winners for their essays and 28 winners for their artwork, and they were awarded certificates.

In addition to this required document, the finance department provides more detailed information on general fund (operating fund) year-to-date expenditure and revenue activity, a projected ending fund balance, a cash at County report, and an investment summary. This information is summarized in this December 2024 financial presentation, based upon the companion consent agenda item: Acceptance of the Financial Reports as of December 31, 2024.

## NEW BUSINESS – APPOINTMENT OF BOARD REPRESENTATIVE TO THE STUDENT REPRESENTATIVE SELECTION COMMITTEE

At the request of the board president, the appointment of a board member to the selection committee established by the superintendent for the selection of a student representative to the board of directors was presented for approval. Director Adkins was selected.
