The meeting opened at 4:30 p.m.


- CALL TO ORDER: Board President Mitchell called the meeting to order.

INFORMATION/DISCUSSION - ASSOCIATED STUDENT BODY BUDGET 2025-26

The Associated Student Body (ASB) budget is a consolidation of the individual school budgets from five middle schools and four high schools. The budgets are developed by student leaders at each school under the guidance of their respective ASB advisors.

The total proposed ASB appropriation for 2025-26 is \$3.7 million to support student activities, athletics, community service projects, and philanthropic contributions. The high school ASB budgets comprise the majority of the total ASB budget and, accordingly, the ASB officers from

each high school provided the board with a presentation of their preliminary plans. Included in both revenues and expenditures are \$35,000 in contingency funds (\$25,000 Activities and \$10,000 Private Moneys) for unforeseen activities that are not already included within individual school budgets. Should any revision be necessary, the students have ample time to make final adjustments prior to the end of the 2024-25 school year. Formal adoption of the ASB fund is scheduled for the August 19, 2025 regular board meeting, along with other 2025-26 district funds.

NEW BUSINESS - ELEMENTARY SCIENCE (K-5) CURRICULUM ADOPTION (FIRST READING)

Since October 2024, staff have been working toward a <u>recommendation for adoption</u> of new instructional resources to best support student learning and achievement in elementary school science. In a process following 2311 and Procedure 2311P, an instructional materials review committee was formed to evaluate materials according to the required criteria outlined in Procedure 2311P. Staff presented the recommendation for Elementary School Science instructional materials to the Instructional Materials Committee, which then recommended these materials to the superintendent for his review and referral for consideration by the board of directors for adoption. The <u>recommended elementary school science instructional material</u> is OpenSciEd, an open educational resource, published in collaboration with Kendall Hunt and Carolina Biological. If adopted for district use, these materials will be implemented with a two-year phase in model starting September 2025. The estimated cost for the elementary school science instructional resources and professional learning is \$2,100,000. This cost is budgeted as part of the P-5 Instructional Curriculum Adoption Instructional Materials Budget, and will be phased in over the 2025-2027 school years.

NEW BUSINESS – POLICY 2410 HIGH SCHOOL GRADUATION REQUIREMENTS, PROPOSED REVISION (FIRST READING)

Proposed <u>revisions to Policy 2410</u>, High School Graduation Requirements, were provided for first reading with second reading and adoption to be recommended at a future board meeting. Proposed revisions include revising graduation year dates in anticipation of the next group of ninth graders starting high school in the 2025-26 school year.

The meeting was adjourned at 6:55 p.m.
