INFORMATION/DISCUSSION – GRADUATION UPDATE: CLASS OF 2025 AND PREVIEW OF SUMMER GRADUATION

Commencement ceremonies for students in the class of 2025 were held on June 12 for Sequoia High School and June 14 for Everett High School, Cascade High School, and Henry M. Jackson High School. Each high school engaged students in preparation for graduation and to ensure each senior makes necessary progress toward on-time graduation and college- and career-readiness for graduation in June or for the August 14 summer commencement ceremony. The board heard a [status report](#) on the class of 2025 with specific information about strategies and interventions to help students meet graduation requirements and how school staff are implementing emergency waivers of graduation requirements for students in this class who have demonstrated post-secondary readiness.

INFORMATION/DISCUSSION – THIRD QUARTER FINANCIAL REPORT

In addition to this required document, the finance department provides more detailed information on general fund (operating fund) year-to-date expenditure and revenue activity, a projected ending fund balance, a cash at County report, and an investment summary. This information is summarized in this third quarter financial presentation, based upon the companion consent agenda item: Acceptance of the Financial Reports as of May 31, 2025.
