WHEREAS, the Revised Code of Washington 4.96.010-020 describes how a person with a damages claim against a government entity must notify the entity at least 60 days before filing a lawsuit; and

WHEREAS, the Revised Code of Washington 4.96.010-020 requires each government entity to identify an agent and the agent's address for the purpose of receipt of such notice; and


WHEREAS, the name and address of the district's agent must be filed with the office of the Snohomish County Auditor.






