## **RESOLUTION NO. 654**

A Resolution of the Board of Directors (the "Board") of Everett School District No. 2 (the "District") declaring certain real property rights to be surplus for the purpose of authorizing the conveyance of the surplus real property rights, and further authorizing the acquisition of other real property rights, all subject to approval of a boundary line adjustment.

WHEREAS, the District is authorized under RCW 28A.335.090 to dispose of real property rights which are no longer required for school purposes;

WHEREAS, the District holds record title to that certain real property more particularly described on Exhibit "A", attached hereto and made a part hereof by this reference ("Surplus District Property"), which is currently used by C & B Enterprises.

WHEREAS, C & B Enterprises holds record title to that certain real property; more particularly described on Exhibit "B", attached hereto and made a part hereof by this reference ("C & B Property"); which is currently used by C & B Enterprises;

WHEREAS, the Board has determined that the Surplus District Property is not needed for school purposes;

WHEREAS, the Board has further determined that conveying its rights in the Surplus District Property for fair market value is in the best interest of the District and will not interfere with the District's current educational program and related activities, but will enhance such program and activities;

WHEREAS, the Board has further determined that acquiring the rights of C & B Enterprises in and to the C & B Property for fair market value will enhance the District's current educational program and related activities; and

WHEREAS, the conveyance of the District's rights in the Surplus District Property and the District's acquisition of the rights of C & B Enterprises in and to the C & B Property requires the approval of a boundary line adjustment.

NOW, THEREFORE, be it resolved that:

- (a) the Board declare, and hereby declares, the Surplus District Property to be surplus to the District's needs, if any, for use of the Surplus District Property for school purposes, such declaration being made for the sole purpose of conveying the District's rights in the Surplus District Property, pursuant to the above-noted statutory authorization, to C & B Enterprises for fair market value; and
- (b) the Board authorize, and hereby authorizes, the Superintendent of the District (or the Superintendent's designee) to enter into an agreement to: (i) convey the District's rights in the Surplus District Property to C & B Enterprises for fair market value after approval of the boundary line adjustment; (ii) require C & B Enterprises to apply for, and pay all costs and expenses of, the boundary line adjustment; (iii) acquire the rights of C & B Enterprises in and to C & B Property for fair market value after the approval of the boundary line adjustment; and (iv) execute, acknowledge and deliver all necessary documents, and do any and all other things necessary and advisable to be done to accomplish the foregoing, all in accordance with applicable law.
