RESOLUTION NO. 721

A Resolution of the Board of Directors ("Board") of Everett School District No. 2 ("District") declaring property adjacent to Mill Creek Elementary School to be surplus and authorizing the sale of said surplus property to Snohomish County ("County")

WHEREAS, the Board is authorized under RCW 39.33.010 to sell, transfer, exchange, lease or otherwise dispose of property to another government entity;

WHEREAS, the Board, pursuant to RCW 39.33.020, is authorized to dispose of property to another government entity without a public hearing if the estimated value of the property is below fifty thousand dollars;

WHEREAS, the District owns that certain real property more particularly described on Exhibit A attached hereto and made a part hereof by this reference ("Property");

WHEREAS, the Board, based on an appraisal prepared for the District, estimates the value of the Property to be less than fifty thousand dollars;

WHEREAS, the Board has determined that the a portion of the Property, described on Exhibit B and attached hereto and made a part hereof by this reference ("Surplus Portion"), is not needed for school purposes; and

WHEREAS, the Board has further determined that selling the Surplus Portion to the County is in the best interest of the District and does not interfere with the District's current educational program and related activities.

NOW, THEREFORE, be it resolved that:

(a) the Board declare, and hereby declares the Surplus Portion to be surplus as it is not needed by the District for school purposes, such declaration being made for the sole purpose of selling the Surplus Portion, in whole or in part, pursuant to the above-noted statutory authorization; and

(b) the Board authorize, and hereby authorizes, the Superintendent of the District (or her designee) to: (i) sell the Surplus Portion to the County and (ii) execute, acknowledge and deliver all necessary documents, and do any and all other things necessary and advisable to be done to accomplish the foregoing sale of the Surplus Portion, all in accordance with applicable law.
