# EVERETT, WASHINGTON RESOLUTION NO. 481

WHEREAS, the Mill Creek Elementary School site would be contiguous to the current city limits of the City of Mill Creek as a result of the East Neighborhood annexation; and

WHEREAS, the Board of Directors has determined that it is in the best interests of the District to authorize the Superintendent to implement appropriate actions to include the Mill Creek Elementary School property with the East Neighborhood annexation to the City of Mill Creek; and

WHEREAS, RCW 28A.335.110 authorizes the board of directors of a school district to petition the City of Mill Creek to annex the Mill Creek Elementary School property;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE EVERETT SCHOOL DISTRICT NO. 2, EVERETT, WASHINGTON, as follows:

#### Section 1. Annexation

The Superintendent of the District is hereby authorized to inititate a petition to annex the Mill Creek Elementary School property to the City of Mill Creek in accordance with RCW 28A.335.110, or to otherwise achieve such annexation in accordance with other applicable law.
