WHEREAS, as of this date final salary schedules and other applicable terms of employment for the 1987-88 school year have not been adopted;

NOW, THEREFORE, BE IT RESOLVED as follows:

- 1. Individual employment contracts shall be issued forthwith to all certificated administrators entitled to an offer of employment for the 1987-88 school year;
- 2. The Board hereby adopts the 1986-87 certificated administrators employee salary schedule on an interim basis for application to the 1987-88 school year exactly as said schedules were applied in 1986-87, that is, without additional salary, experience or educational credits and;
- 3. The Superintendent is hereby directed to cause to be delivered forthwith to all certificated administrators to be offered employment for the 1987-88 school year a completed contract in the form attached hereto and consistent with the interim 1987-88 salary schedules as they apply to each contract recipient.
