- 3. The Superintendent is hereby directed to cause to be delivered forthwith to all nonsupervisory certificated personnel to be offered employment for the 1987-88 school year a completed contract in the form attached hereto and consistent with the interim 1986-87 salary schedules as they apply to each contract recipient.
