RESOLUTION NO. 32

STUDENT BODY ASSOCIATIONS IN THE DIFFERENT SCHOOLS SHOULD AND DO HAVE A GOOD DEAL OF AUTONOMY IN THE MANAGEMENT OF THEIR OWN AFFAIRS. AT TIMES, HOWEVER, THEIR INTERESTS AND ACTIVITIES MAY AFFECT THE SCHOOL DISTRICT AND IT IS WISE AND NECESSARY THAT THEIR PLANS BE CHECKED WITH THE SUPERINTENDENT TO MAKE SURE THAT THEY CONFORM TO GOOD POLICY AND REGULATIONS OF THE BOARD OF EDUCATION.

IT IS IMPOSSIBLE HERE TO DESCRIBE ALL OF THE SITUATIONS THAT MIGHT ARISE WHICH SHOULD BE SUBMITTED FOR APPROVAL BEFORE ACTUALLY ENGAGING IN THE ACTIVITY, ENTERPRISE, ETC. IN LIEU THEREOF THE FOLLOWING GUIDING PRINCIPLES CONCERNING STUDENT ACTIVITIES ARE SET DOWN AND APPROVED:

1. THE SCHOOL PRINCIPAL HAS FULL VETO POWER IN ALL STUDENT BODY MATTERS.
2. NEW ACTIVITIES AND ENTERPRISES THAT VARY FROM THE USUAL PATTERN SHOULD BE CHECKED BY THE PRINCIPAL WITH THE SUPERINTENDENT BEFORE THEY ARE UNDERTAKEN. PARTICULARLY IS THIS TRUE IN THE CASE OF TRANSACTIONS INVOLVING CREDIT, UNUSUAL COSTS, HEALTH AND SAFETY OF PUPILS, OR PUBLIC RELATIONS.
3. STRICTLY SPEAKING, ALL STUDENT BODY EQUIPMENT AND FACILITIES ARE THE PROPERTY OF THE SCHOOL DISTRICT AND, THEREFORE, ARE SUBJECT TO THE CONTROL OF THE BOARD OF EDUCATION. INsofar AS POSSIBLE, HOWEVER, THE BOARD OF EDUCATION WILL RESPECT THE WISHES OF THOSE WHO PURCHASE EQUIPMENT OR MAKE IMPROVEMENTS FOR THE SCHOOLS. STUDENT ASSOCIATIONS AND OTHERS DESIRING RESTRICTIONS ON THE PLACEMENT OR USE OF SUCH EQUIPMENT AND IMPROVEMENTS, OR AGREEMENTS ON THEIR MAINTENANCE AND REPLACEMENT, OR SUCH OTHER CONSIDERATIONS, SHOULD PRESENT THEIR REQUESTS TO THE SUPERINTENDENT, WHO, IN TURN, WILL PRESENT THEM TO THE BOARD WITH HIS RECOMMENDATION. REQUESTS APPROVED BY THE BOARD SHOULD BE FILED FOR FUTURE REFERENCE.
4. STUDENT BODIES SHOULD BE CAREFULLY ORGANIZED UNDER CONSTITUTIONS OR CHARTERS WHICH CLEARLY RELATE HOW THE ASSOCIATIONS AND ITS SUBSIDIARIES FUNCTION. THESE CONSTITUTIONS OR CHARTERS AND SIGNIFICANT CHANGES THEREIN SHOULD BE SUBMITTED TO THE SUPERINTENDENT FOR HIS REVIEW AND RECOMMENDATION TO THE BOARD OF EDUCATION.
5. FINANCIAL STATEMENTS SHOULD BE SUBMITTED AT LEAST ANNUALLY FOR EACH STUDENT ASSOCIATION, INCLUDING ITS SUBDIVISIONS, TO THE BUSINESS MANAGER FOR REPORTING TO THE BOARD OF EDUCATION.
