# RESOLUTION NO. 34

WHEREAS, at an election held in Everett School District No. 2, Snohomish County, Washington, on the 7th day of November, 1950, the number and proportion of the qualified electors of the school district required by law for the adoption thereof voted in favor of a proposition authorizing the issuance of general obligation bonds of the district in the amount of \$1,000,000.00 to provide funds for certain capital purposes, and

WHEREAS, it is deemed necessary and to the best interests of the school district, its pupils and inhabitants, that said bonds be now issued and sold to provide funds for such purposes,

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of Everett School District No. 2, Snohomish County, Washington, as follows:

Section 1. That there now be issued and sold \$900,000.00 of general obligation bonds of the district as authorized by the electors thereof at a special election held therein on November 7, 1950, for the purpose of providing funds for certain capital expenditures as provided in Resolution No. 27 of the board of directors of the district adopted July 10th \_\_\_\_\_, 1950.

Said bonds shall be dated October 1, 1952, shall be in denominations of \$1,000.00 each, shall be numbered from 1 to 900, inclusive, and shall bear interest at a rate of not to exceed 6% per annum, payable semi-annually on the first day of April and October of each year, as evidenced by coupons to be attached to said bonds.

Both principal and interest of said bonds shall be payable in lawful

money of the United States of America at the office of the Treasurer of Snohomish County in Everett, Washington, and said bonds shall mature in order of their number as follows:
