RESOLUTION NO. 38

A RESOLUTION providing for a special levy of four mills for the operation of kindergartens and other school purposes.

WHEREAS, the State Legislature has failed to provide sufficient funds to enable Everett School District #2 to operate its schools in an adequate manner, particularly with reference to the operation of kindergartens; and

WHEREAS, without a special levy it will be necessary to close or curtail the kindergarten program and in order to operate such kindergartens it is necessary to provide additional funds to supplement funds otherwise available for such purposes and such additional funds is hereby declared to be the sum of \$143,498.00;

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of the Everett School District No. 2, of Snohomish County, Washington, that said funds be raised as follows:

1. \$143,498.00 by the levy in the year 1953 of a tax of four mills without regard to any tax limitations provided by law for the operation of kindergartens and other school purposes in addition to funds otherwise available for said purposes.

BE IT FURTHER RESOLVED: That an emergency exists requiring a special election, whereat the voters within said Everett School District No. 2 may ratify or reject the proposition herein mentioned.

BE IT FURTHER RESOLVED: That a special election shall be held in Everett School District No. 2 of Snohomish County, Washington, on the 26th day of May, 1953, at which there shall be submitted to the qualified voters of said school district the following proposition, to-wit:

1. Shall Everett School District No. 2, Snohomish County, Washington be authorized to levy in the year 1953, an additional tax of four mills, without regard to any tax limitations provided by law, to secure funds in the estimated amount of \$143,498.00 for the operation of kindergartens and other school purposes in addition to funds otherwise available for said purposes.

BE IT FURTHER RESOLVED: That the Clerk of the Board of Directors of Everett School District No. 2, Snohomish County, Washington, be and he is hereby directed to provide ballots, poll books and tally sheets, to provide polling places and deliver ballots, poll books and tally sheets to the Precinct Election Officers at the polling places; to publish and post notices of said election in the manner and for the time required by law.

BE IT FURTHER RESOLVED: That the polling places be open from 8 A.M. to 8 P. M.

BE IT FURTHER RESOLVED: That the said district clerk cooperate in every way with the Supervisor of Elections for Snohomish County, Washington.

BE IT FURTHER RESOLVED: That the proposition submitted by this Resolution shall appear upon the ballot in substantially the following form:

PROPOSITION NO. L

Shall Everett School District No. 2, Snohomish County, Washington, be authorized to levy in the year 1953, an additional tax of four mills, without regard to any tax limitations provided by law, to secure funds in the estimated amount of \$143,498.00 for the operation of kindergartens and other school purposes, in addition to funds otherwise available for said purposes.
