WHEREAS, the Everett School District has been operating a handicapped program in the Everett Schools since July 1, 1948 as provided in Chapter 120, Laws of 1943, Laws amendatory and supplementary thereto, and Chapter 240, Laws of 1947, and

WHEEAS, 70 students are in regular daily attendance and 300 edditional students are given tests and provided with speech and hearing therapy, and

WHEREAS, fees for this program have been supplemented by allotment of funds by the State Superintendent of Fublic Instruction, and

WHEREAS, the projected budget for this program for next year amounts to \$13,000. with educational unit and attendance support amounting to \$17,005.36, leaving a necessity of allotment from the handicapped program of \$26,390.60 and,

WHEREAS, allotment for this progrem for the first 7 months, it appears that the total yearly shortage of allotment will be \$2,318.57 and,

WHEREAS, the State Superintendent of Public Instruction has informed us there is a shortage of funds for handicapped allotment and.

WHEREAS, it is our understanding that the Govenor of the State of Washington has an emergency fund that can be used therefrom for these purposes,

NOW THEREFORE BE IT RESOLVED that the Board of Directors of Everett School District No. 2 respectfully petition the Covenor of the State of Washington to transfer to the handicapped fund a sufficient amount to take care of the handicapped budget as projected by the Everett School District.
