RESOLUTION NO. 54

- I. WHEREAS, there is an existing need in Everett School

 District No. 2, Snohomish County, Washington, for the acquisition of additional sites for new school buildings, sufficient to meet the requirements of the district, and moneys necessary to make prelimiand build temporary class rooms; nary plans for such new buildings/ and
- II. WHEREAS, many of the existing school buildings and equipment therein need extensive repairs, improvements and rehabilitating; and III. WHEREAS, the State Legislature has failed to provide sufficient funds to enable Everett School District No. 2, Snohomish County, Washington, to operate kindergartens in its schools and without a special levy it will be necessary to close the kindergarten program, and in order to operate such kindergartens it will be necessary to provide additional funds for such purposes in the sum of \$180,000.00; and
- IV. WHEREAS, the funds available for the purposes outlined in Paragraphs I and II above are also hopelessly inadequate, it is therefore necessary to provide additional funds for such purposes; and V. WHEREAS, it is necessary to acquire sites for new school buildings to meet the needs of the district, and to make preliminary plans for such new school buildings, and other capital outlays; and VI. WHEREAS, it is necessary to repair, improve, modernize and rehabilitate existing school buildings, school facilities and equipment; includings, school facilities and
- VII. WHEREAS, by reason of increased costs, moneys sufficient to carry out said plans are not available and the estimated cost of said build temporary class rooms additional sites, preliminary plans for new school buildings and capital outlays are hereby declared to be in addition to funds otherwise available for such purposes the sum of \$100,000.00; and the estimated cost of repairs, improvements, modernization and rehabilitation of existing school buildings, school facilities and equipment, includings temporary class rooms addition to funds otherwise

available for such purposes, is declared to be the sum of \$180,000.00;

- VIII. NOW, THEREFORE, BE IT RESOLVED By the Board of Directors of Everett School District No. 2, Snohomish County, Washington, that said additional funds be raised as follows:
- 1. \$180,000.00 by the levy in the year 1955 of a tax of approximately 3.83 mills, without regard to any tax limitations provided by law, for the operation of kindergartens for two years.
- 3. \$100,000.00 by the levy in the year 1955 of a tax of approximately 2.13 mills, without regard to any tax limitations provided by law, for the purpose of providing sites and preliminary build temporary class rooms plans for new buildings/and other capital purposes.
- IX. BE IT FURTHER RESOLVED: That an emergency exists requiring a special election, whereat the voters within said Everett School District No. 2 may ratify or reject the three propositions herein mentioned.
- X. BE IT FURTHER RESOLVED: That a special election shall be held in Everett School District No. 2, Snohomish County, Washington, on the 24th day of May, 1955, at which there shall be submitted to the qualified voters of said District the following propositions, to-wit:
 - 1. Shall Everett School District No. 2, Snohomish County,
 Washington be authorized to raise the sum of \$180,000.00
 by a levy in the year 1955 of approximately 3.83 mills,
 without regard to any tax limitations provided by law, to
 secure funds in the said sum of \$180,000.00 for the
 operation of kindergartens for two years.

- 3. Shall Everett School District No. 2, Snohomish County,
 Washington, be authorized to raise the sum of \$100,000.00
 by the levy in the year 1955 of a tax of approximately
 2.13 mills, without regard to any tax limitations provided
 by law, to secure funds in the said amount of \$100,000.00
 for the purpose of acquiring sites and making preliminary
 building temporary class rooms
 plans for new school buildings and other capital purposes,
 in addition to funds otherwise available for said purpose.
- 2. Shall Everett School District No. 2, Snohomish County,
 Washington, be authorized to raise the sum of \$180,000.00
 by the levy in the year 1955 of a tax of approximately 3.83
 mills, without regard to any tax limitations provided by
 law, to secure funds in the said amount of \$180,000.00
 for the purpose of maintaining, improving, repairing, modernizing and rehabilitating existing school buildings, facilities
 and equipment, includingxtemporraryxxlexxxremms, for two years,
 in addition to funds otherwise available for said purpose.
- XI. BE IT FURTHER RESOLVED: That the Clerk of the Board of Directors of Everett School District No. 2, Snohomish County, Washington, be and he is hereby directed to provide ballots, poll books and tally sheets, to provide polling places and deliver ballots, poll books and tally sheets to the Precinct Election Officers at the polling places; to publish and post notices of said election in the manner and for the time required by law.
- XII. BE IT FURTHER RESOLVED: That the polling places be open from 8 A.M. to 8 P.M.
- XIII. BE IT FURTHER RESOLVED: That the said district clerk cooperate in every way with the Supervisor of Elections for Snohomish County, Washington.
- XIV. BE IT FURTHER RESOLVED: That the propositions submitted by this Resolution shall appear upon the ballot in substantially the following form:
