

RESOLUTION NO 19

WHEREAS, EVERETT SCHOOL DISTRICT NO. 2, SNOHOMISH COUNTY, WASHINGTON, HAS PREPARED FOR THE YEAR 1948-1949 A FINAL BUDGET IN THE AMOUNT OF \$1,715,000.00, AND,

WHEREAS, THE EXTRA DEMANDS PLACED UPON THE SCHOOL DISTRICT FOR ITS OPERATION DURING THE 1948-1949 SCHOOL YEAR IS EXCEEDING THAT FIGURE, AND

WHEREAS, AT THIS DATE SUFFICIENT BALANCES DO NOT EXIST IN SAID GENERAL FUND BUDGET TO PERMIT THE PAYMENT OF ALL OF THE OBLIGATIONS INCURRED DURING THE 1948-1949 SCHOOL YEAR, AND

WHEREAS, IT HAS BEEN HELD ILLEGAL TO DEFER INTO THE FOLLOWING FISCAL YEAR ANY OBLIGATIONS WHICH BELONG TO A PRIOR YEAR, AND

WHEREAS, TO PAY ALL OF THE OBLIGATIONS OF SAID EVERETT SCHOOL DISTRICT BELONGING TO ITS 1948-1949 SCHOOL YEAR WILL NECESSITATE AN EMERGENCY APPROPRIATION IN THE AMOUNT OF \$10,000.00, WHICH IS \$10,000.00 IN EXCESS OF THE BUDGETED APPROPRIATIONS THEREFOR, AND

WHEREAS, SECTIONS 4867 AND 4868 OF REMINGTON'S REVISED STATUTES PROVIDE FOR THE ADOPTION OF A RESOLUTION DECLARING AN EMERGENCY AND MAKING AN EMERGENCY APPROPRIATION, THEREFOR,

NOW THEREFORE BE IT RESOLVED, THAT AN EMERGENCY EXISTS AND THAT AN EMERGENCY APPROPRIATION IN THE AMOUNT OF \$10,000.00 BE, AND HEREBY IS, MADE; AND THAT THE UNPAID OBLIGATIONS OF SAID EVERETT SCHOOL DISTRICT BE PAID AS OF JULY 10, 1949, AND BE CONSIDERED A PART OF THE EXPENDITURES FOR THE FISCAL YEAR ENDED JUNE 30, 1949.

AND BE IT FURTHER RESOLVED, THAT THE SECRETARY OF SAID SCHOOL DISTRICT BE INSTRUCTED TO FILE A CERTIFIED COPY OF THIS EMERGENCY RESOLUTION WITH THE COUNTY AUDITOR, COUNTY TREASURER, AND COUNTY SUPERINTENDENT OF SCHOOLS AS AUTHORITY TO ISSUE SAID WARRANTS ON THE ORDER OF THE BOARD OF DIRECTORS.
