About Free Tax Preparation

- This service is available for **households earning \$51,000 a year or less.**
- Tax returns are prepared by **United Way multilingual volunteers.**
- **No appointment necessary.**
- You may be eligible for claiming child/student related credits for **larger refunds.**
- We can help you apply for an **Individual Taxpayer Identification Number (ITIN).**
- **Basic tax returns only.** No rental income, sale of property or stock. Business expenses limited to \$5,000.
- Find out which **health and food assistance programs** you and your family are eligible for.

What to Bring

- **Picture ID REQUIRED.**
- **Social Security card or ITIN number and dates of birth** for everyone on your return.
- **W-2s** or other income statements for you and your spouse from ALL your employers.
- **Any 1099 forms** (for income from interest, dividends, retirement, social security or unemployment).
- Name, address and taxpayer identification number of **child care provider**, if you pay for child care.
- Records of **student loan payments**.
- Records of payments for educational expenses, such as **college tuition**.
- **Mortgage interest and property tax statements**, if you own a home.
- **Bank account number** for direct deposit.
- A copy of **last year's tax return**, if you have it.
- If filing jointly, **both filer and spouse must be present** to file electronically.

Lo Que Necesita Traer

- **Identificación con photo OBLIGATORIO.**
- **Tarjeta de Seguro Social o número ITIN** así como también fechas de nacimiento de todas las personas en su declaración.
- **W-2s** o cualquier otras declaraciones para usted y su cónyuge de TODOS sus empleadores.
- **Cualquier formulario 1099** (de ingresos por intereses, dividendos, jubilación, seguro social o desempleo).
- Nombre, dirección, y número de identificación fiscal de la **guardería** si usted paga por el cuidado de sus niños.
- Los registros de **pagos de préstamos estudiantiles**.
- Los registros de pagos por gastos educativos, tales como la **matrícula universitaria**.
- **Interés de la hipoteca y declaraciones de los impuestos a la propiedad** si usted es dueño de una casa.
- **Número de cuenta bancaria**, para el depósito directo.
- Una copia de la **declaración de impuestos del año pasado**, si la tiene.
- Si está presentando una declaración conjunta, **los dos tienen que venir tanto el contribuyente como su cónyuge** para poder presentar la declaración electrónicamente.
