Adoption of the Operating Budget for Fiscal Year 2013-14

WHEREAS, RCW 28A.505.050 and WAC 392-123-054 requires that the district's fiscal year 2013-14 budget be adopted and tax levies certified on or before August 31, 2013; and

WHEREAS, a public notice was published on August 13, 2013 and August 20, 2013 announcing that on August 27, 2013, the board of directors of Everett Public Schools would hold a public meeting for the purpose of fixing and adopting the 2013-14 budget; and

WHEREAS, RCW 28A.320.330 requires an operating transfer from the Capital Fund to the General Fund during the month of November in the amount of \$1,350,000 for the application and modernization of technology systems for operations and instruction and for major equipment repair, painting of facilities, and other major preventive maintenance purposes; and

WHEREAS, the district has certified for 2014 a General Fund Maintenance and Operations Excess Levy in the amount of \$42,969,331, a Debt Service Fund Levy of \$27,475,000, and a Capital Projects Fund Levy in the amount of \$8,000,000;

**NOW, THEREFORE, BE IT RESOLVED** that the Board of Directors of Everett School District No. 2, Snohomish County, Washington, does hereby adopt the Operating Budget for Fiscal Year 2013-14 as follows:
