Member middle schools will be billed also in September on the basis of the average monthly enrollment of October, November and December, and the number of sports/activities in which the schools are enrolled. A Labor and Industries (L&I) billing will also be sent to each member school at that time.

# Roles and Responsibilities

## 1. WIAA School Director Contact:

#### Role:

This person is a school director for each school district that is annually selected by their board of directors to serve as the WIAA contact person. This person will receive the mailing and e-mail information from the WIAA and will work closely with their WIAA school spokesperson(s).

## Responsibilities:

- a. Keep the school district administration and board of directors updated on WIAA issues.
- b. Meet monthly with the WIAA school spokesperson(s), serve as the liaison between member school's activity programs and district administration and board of directors.
- c. Assist the school district in taking a position on the annual WIAA amendments.
- d. Be the school district contact for the WIAA IAC/WSDA representative and provide them input on WIAA amendments, concerns and issues.
- e. Facilitate an opportunity for the school athletic/activity director(s) to address the school board on a regular basis.

# 2. WIAA School Spokesperson

#### Role:

This person is designated by their school district as the spokesperson to the WIAA for each WIAA member school. This person is generally the principal or his/her designee from each member school in the school district. This person will receive the mailings and e-mail information from the WIAA and will work closely with their WIAA School Director contact person. This person will gather input on behalf of their member school report back actions from league and WIAA District meetings.

## Responsibilities:

- a. Keep all needed persons at the school level updated on WIAA issues.
- b. Meet monthly with the WIAA School District contact person, serve as the liaison between member school's activity programs and district administration and board of directors.
- c. Assist the school coaches, advisors and administration in taking a position on the annual WIAA amendments.
- d. Be the school contact for the WIAA District representative and provide them input on WIAA amendments, concerns and issues.
- e. Work with the School District Contact person to facilitate an opportunity for the high school athletic/activity director(s) to address the school board on a regular basis.

### SCHOOL BOARD RESOLUTION DELEGATING AUTHORITY TO WIAA

WHEREAS Chapter 32, Laws of 1975-76, 2nd Ex. Sess. grants authority to each school district board of directors to control, supervise and regulate the conduct of interschool athletic activities and other interschool extracurricular activities of an athletic, cultural, social, or recreational nature for students in the district.

WHEREAS the Washington Interscholastic Activities Association is a voluntary, nonprofit entity which has satisfied the conditions, expressly set forth in Chapter 32, Laws of 1975-76, 2nd Ex. Sess. and has further been approved by the State Board of Education in action taken on August 17, 1977.					
WHEREAS the board of directors of <u>Everett</u> School District or School being otherwise fully informed of the rules and regulations of the Washington Interscholastic Activities Association as approved by the State Board of Education and recognizing that said rules and regulations provide for private sponsorship of post-season tournaments for extracurricular activities by WIAA, consent to abide by such rules and regulations.					
NOW THEREFORE, the board of directors of the <u>Everett</u> School District or School hereby delegates to the Washington Interscholastic Activities Association the authority to control, supervise and regulate interschool activities consistent with the rules and regulations of WIAA. The Board of Directors retains the right to establish eligibility standards that meet or exceed the rules and regulations of WIAA.

Beginning July 1, 1988, interscholastic sports officials were covered by Washington State Labor and Industries via a common rate and payment system that eliminated game-by-game calculations and record keeping by school and/or district business offices. WIAA will guarantee payment of L&I premiums for WOA registered officials for all interscholastic activities under WIAA's jurisdiction and will assess WIAA member schools via classification rates at the same time service fees are billed. Officials L&I coverage is only in effect for activities authorized and offered by School Board approval and listed on the school's WIAA membership form.					

To improve the flow of information each School Board may select a SCHOOL DIRECTOR to be the WIAA School Board Contact. The WIAA School Board Contact receives the following WIAA mailings: Newsletters, Executive Board Minutes, Representative Assembly Minutes and Amendments, and the Annual Report. The WIAA School Board contact is expected to serve as the liaison between the member school's activities programs and the other school Board Members. (See Attachment)
