## SNOHOMISH COUNTY SCHOOLS MCKINNEY-VENTO MEETING 08/12/16

#### **INTRODUCTION**

Amy welcomed everyone to the meeting and introduced Cynthia Jones, Director of Categorical Programs, EPS. Cynthia welcomed special guests, Jess Lewis and Ella DeVerse from OSPI. Amy presented a brief overview of <u>statistics of homeless students in Snohomish County Public Schools for 2014-15</u>.

#### **COCOON HOUSE (ELYSA HOVARD)**

Elysa Hovard of <u>Cocoon House</u> gave an overview of services offered through Cocoon House.



- ➤ Safe Place: A youth in crisis can go to a designated "Safe Place" or Get Help 24/7: Call or text 425.877.5171 or email <a href="mailto:safeplace@cocoonhouse.org">safeplace@cocoonhouse.org</a>. An advocate will help figure out the next steps to making sure the youth has a safe place to go, and can meet with them within 45 minutes anywhere in the county if needed. "Safe Places" in the county include public libraries and public transportation buses.
- ➤ **Housing Navigators:** Cocoon House offers housing navigation services for youth 13-24 years old.
- Advocates: Mobile advocates have the ability to meet with youth where they're at, including within the schools if needed.
- ➤ <u>U-Turn drop-in center</u>: Located at 1421 Broadway, is a place where youth can go for support services, i.e.; food, housing navigator, basic necessities, and a Peer Mentor Program.
- ➤ Shelters: Cocoon House operates 4 shelters in Snohomish County (Monroe, Arlington, and two in Everett) they also have a regional collaboration with other counties' youth shelters. Youth who are staying at a shelter, must agree to engage in the program expectations, attend school, and abide by curfew. If successful at the interim shelter, participants can get into long term housing.
- ➤ **Prevention Services:** Cocoon House also provides prevention services to intervene before loss of housing occurs <u>click here for more information</u>.

McKinney-Vento staff requested that Elysa look into amending CH Release of Information Form to include the physical address of the shelter where the student resides so transportation needs can be clearly determined.

#### **FOSTER CARE UPDATE (JESS LEWIS)**

Jess explained the new Foster Care provisions and gave a brief overview of the OSPI website, the best place to find current information and upcoming changes to the Foster Care Education Program. New Foster rules go into effect on December 10, 2016 and are intended to keep Foster Kids educationally stable with similar provisions to McKinney-Vento. Jess works closely with Shanna McBride mcbrism@dshs.wa.gov 360-902-8474, the Statewide Education Program Manager at Children's Administration. Donna LaFrance is the Regional Education Program Manager for Snohomish County/Region 2.

- ➤ DSHS can pay education related fines and fees for Foster Children.
- ➤ Children in the Foster System can enroll in school without the usually required documents for registration.
- ➤ OSPI will identify Foster status with schools through Cedars.
- ➤ Foster Care Dispute Resolution process which can be accessed on the OSPI website.
- ➤ There are 9,000 kids in McKinney Vento throughout the state and about 4,500 of them are in Foster care.
- Funding can come from DSHS and the Children's Administration to meet the transportation needs of children in Foster care. Other sources such as volunteer drivers or payment of direct transport services like cab fare, may be available.
- ➤ Title 1 funds can be used for transportation of Foster kids when resources from DSHS and foster parents have been exhausted. Jess explained that DSHS has mandate to cooperate with schools.
