WHAT TO BRING

- **Picture ID REQUIRED.**
- **Social Security card or ITIN** number and dates of birth for everyone on your return **REQUIRED.**
- **W-2s** or other income statements for you and your spouse from ALL your employers.
- Form **1095-A, -B, or -C** if anyone on your return had health insurance for any part of 2016. **REQUIRED.**
- Any **1099** forms (for income from interest, dividends, retirement, social security, or unemployment).
- Name, address, and taxpayer identification number of **child care provider**, if you pay for child care.
- Records of **student loan payments.**
- Records of payments for educational expenses, such as **college tuition.**
- **Mortgage interest and property tax statements**, if you own a home.
- **Bank account number** for direct deposit.
- A copy of **last year's tax return**, if you have it.
- **If filing jointly, both filer and spouse must be present** to file electronically.

LO QUE NECESITA TRAER

- **Identificación con photo OBLIGATORIO.**
- **Tarjeta de Seguro Social o número ITIN** así como también fechas de nacimiento de todas las personas en su declaración **OBLIGATORIO.**
- **W-2s** o cualquier otras declaraciones para usted y su cónyuge de TODOS sus empleadores.
- Formulario **1095-A, -B, o -C** si alguien en su declaración tenía seguro de salud durante 2016. **OBLIGATORIO.**
- **Cualquier formulario 1099** (ingresos por intereses, dividendos, jubilación, seguro social, o desempleo).
- Nombre, dirección, y número de identificación fiscal de la **guardería** si usted paga por el cuidado de sus niños.
- Los registros de **pagos de préstamos estudiantiles.**
- Los registros de pagos por gastos educativos, tales como la **matrícula universitaria.**
- **Interés de la hipoteca y declaraciones de los impuestos a la propiedad** si usted es dueño de una casa.
- **Número de cuenta bancaria**, para el depósito directo.
- Una copia de la **declaración de impuestos del año pasado**, si la tiene.
- Si está presentando una declaración conjunta, **los dos tienen que venir tanto el contribuyente como su cónyuge** para poder presentar la declaración electrónicamente.
