RESOLUTION NO. 1044

Jefferson Elementary School Storm Water Detention Tract Conveyance

A Resolution of the Board of Directors (the "Board") of Everett School District No. 2 (the "School District") authorizing execution and delivery on behalf of the District of a Snohomish County Quit Claim Deed and related instruments to accomplish the conveyance of real property and property rights for a storm water detention facility to Snohomish County (the "County").

WHEREAS, the School District owns Lot 2 of Snohomish County Short Plat 09-102385-00-00 SP (AFN 201109075001), in Snohomish County, Washington, a portion of which is more particularly described on Exhibit A and shown on Exhibit B (the "Detention Pond Tract"); and

WHEREAS, On September 1, 2009, the Snohomish County Hearing Officer issued his decision in File No. 09-102385-00-00-SP (the "Decision"), approving subject to conditions the short plat application filed by the School District, and setting forth drainage conditions for the new county road (Cadet Way) authorized in the Decision (the "County Road"); and

WHEREAS, the County has used and maintained, and intends to continue to use and maintain, a storm water detention facility located on the Detention Pond Tract that treats and detains storm water runoff, primarily from the County Road (the "Facility"); and

WHEREAS, the Detention Pond Tract to be conveyed is not currently subject to an authorized school use, is no longer required for school purposes, and has an estimated value of less than \$50,000; and

WHEREAS, the County maintains the Facility on the Detention Pond Tract, creating a situation in which both the County and School District have ownership or maintenance obligations with respect to the same facility, creating management complications and potentially complicating and increasing the cost of administration and risk management; and

WHEREAS, the Intergovernmental Disposition of Property Act, Chapter 39.33 RCW, provides municipal corporations of the State of Washington with the authority to transfer real property on such terms and conditions as may be mutually agreed upon by the proper authorities of such municipal corporations;

NOW, THEREFORE, be it resolved by the Board of Directors, pursuant to Chapter 39.33 RCW, that:

- (a) the Board declare, and hereby declares, the Detention Pond Tract to be conveyed (including the improvements thereupon) is not subject to an authorized school use and is no longer needed for school purposes, and
- (b) that dedication and conveyance of the Detention Pond Tract to the County to facilitate the treatment and detention of storm water runoff from the County Road is beneficial to the County's maintenance of the Facility and will reduce administrative responsibilities and risk management concerns of the School District with respect to the facility and Detention Pond Tract; and
- (c) the Board authorize, and hereby authorizes, the Superintendent of the School District (or the Superintendent's designee) to execute and deliver to the County a Snohomish County Quit Claim Deed in the form attached as Exhibit C, and related instruments, and to do all other things necessary and advisable to be done to accomplish the dedication of the Detention Pond Tract to the County in accordance with applicable law.


