Everett Public Schools participates in the National School Lunch and Breakfast Program sponsored by the USDA. Each entrée comes with a variety of fresh fruit and vegetables, along with 1% white milk or non-fat chocolate milk.

Every day we proudly serve students nutritious meals that include:

- Whole-grain breads, wraps, pasta and rolls
- Self Service Bars that include: broccoli, cauliflower, carrots, apples, oranges, salads, pears, bananas, and other seasonal fruits and vegetables
- On-site homemade items including mac & cheese, lasagna, soup, bread dough, salad dressing and more

- Please write your student ID number on the check
- If cash is sent with your elementary student, please put it in an envelope or bag with the student ID number written on the front

Please visit [My Payments Plus](http://My Payments Plus). Many parents enjoy the convenience of online payments. Families can **access balances**, view purchases, **request low balance email notifications**, or make payments from their computer or smartphone. There is no charge to view purchases, receive email notifications, or check balances. My Payments Plus does charge a small convenience fee to make a deposit. Please allow 24 hours for deposits to show on your student's account. All balances follow your student into the next school year even if your student transfers to another school within the district.

## Extending credit for school meals

The district's approach to extending credit for meals is proactive and reduces potential embarrassment when a student runs out of money on their student meal account. We want the meal service to be a positive experience for all students and minimize the identification and individual impact for a student with insufficient funds.

Payments to deposit money into student meal accounts can be made at the school kitchen, the Food and Nutrition Services office, and online. Online payments can be made at [www.mypaymentsplus.com](http://www.mypaymentsplus.com).

- The goal is for student accounts to remain positive
- All households are accountable for meal charges
- All balances, positive or negative, carry over to the next year
- Parents are notified of unpaid meal charges through an automated phone and email message
- The district does not want to burden any family with unpaid accumulating debt; therefore, any student with insufficient funds will be allowed to charge up to five meals and will then be offered a courtesy meal at no charge. All students will be offered a meal if they enter the line.
- Students accepting a courtesy meal will be able to select from a variety of fresh fruits, veggies and milk, in addition to any of the "grab and go" options offered, which are available for purchase for anyone on any day.
- Food and Nutrition Services will not delay or deny a meal due to a student having insufficient funds
- A la Carte items and non-student purchases cannot be charged
