Contaminants reportedly in some Washington schools' water systems are likely from those old schools' plumbing. Lead pipes in those older schools were used mostly before the 1960s, according to the **Alderwood Water District** website. (This website, has some timely information about water quality, what happened in Flint, Michigan and why we have less reason to worry about water here in our region than Flint, Michigan does.)

The chart at the left indicates the original construction and subsequent renovation dates for Everett Public Schools 26 schools. None of the district's schools are in a before-1960 state. All were either built new after the 1960s or have been renovated after the 1960s.

History, past testing & actions taken

The district tested all schools for lead in drinking water in 2005 – the last time the state funded the cost of such tests in schools. Remediation work at four schools was completed after the 2005 tests.

The district tested Forest View Elementary right after it opened in 2007/2008, and North Middle School again in 2013.

Forest View's test results were resolved by thoroughly flushing out new construction detritus, and North's ongoing and annual remediation includes changing the filters on faucets and drinking.

Some background

In 2009, The State Board of Health adopted a revised "School Rule" in 2009, WAC 246-366A, that requires testing water testing in schools.

However, the legislature prohibited implementing the requirements because of lack of funding the prohibition is still in place, as of spring 2016.
