

RESOLUTION NO. 100

A RESOLUTION of the Board of Directors of Everett School District No. 2, Snohomish County, Washington, providing for the submission of two propositions to the qualified electors of the district at a special election to be held therein on May 28, 1963; the first authorizing the levy of an excess tax of approximately 10 mills for the Building Fund to provide \$715,000.00 for the purpose of securing additional sites, new buildings, equipment, and the modernization of existing buildings. The second authorizing the levy of an excess tax of approximately 10 mills for the General Fund to provide \$715,000.00 for the purpose of repairing, improving and rehabilitating existing school buildings, facilities and equipment, providing school supplies, and the maintenance of salaries to attract competent personnel.

WHEREAS, there is an existing need in Everett School District No. 2, Snohomish County, Washington, for the acquisition of additional sites for, and the construction and equipment of, new school buildings sufficient to meet the requirements of the district and modernization of existing buildings, and

WHEREAS, many of the existing school buildings and equipment therein, need extensive repairs, improvements and rehabilitating, and

WHEREAS, The funds available for such purposes are hopelessly inadequate and it is therefore necessary to provide additional funds for such school purposes, and

WHEREAS, plans have heretofore been made for the acquisition of sites for, and the construction and equipment of, new school buildings to meet the needs of the district and the modernization of existing buildings, and for the repair, improvement, and rehabilitation of existing school buildings, school facilities and equipment, and purchase of additional supplies; and

WHEREAS, by reason of increased costs, moneys sufficient to carry out such said plans are not available, and the estimated cost of said additional sites, new buildings, equipment and modernization of existing buildings is hereby declared to be, in addition to funds otherwise available for such purpose, the sum of Seven Hundred and Fifteen Thousand, ~~Four Hundred and Nine Dollars and forty two cents~~ (\$715,000.00), and the estimated cost of

the repairs, improvement and rehabilitation of existing school buildings, facilities and equipment, additional supplies and the maintenance of salaries to keep pace with the increased cost of living and to attract competent personnel, in addition to funds otherwise available for such purpose, is declared to be the sum of Seven Hundred and Fifteen Thousand, ~~Four hundred and nine dollars and forty-two cents~~ (\$715,000.00), now, therefore,

BE IT RESOLVED: by the Board of Directors of Everett School District No. 2 of Snohomish County, Washington, that said additional funds be raised as follows:

1. \$715,000.00 by the levy in the year 1963 of a tax of 10 mills, without regard to any tax limitations provided by law, for the purpose of acquiring sites for, and the construction and equipment of new school buildings and modernization of existing buildings.
2. \$715,000.00 by the levy in the year 1963 of a tax of 10 mills, without regard to any tax limitations provided by law, for the purpose of maintenance, repair, improvement, and rehabilitation of existing school buildings, facilities and equipment, purchase of additional supplies, and payment of salaries.

BE IT FURTHER RESOLVED: That an emergency exists requiring a special election, where the voters within said Everett School District No. 2 may ratify or reject the two propositions herein mentioned.

BE IT FURTHER RESOLVED: That a special election shall be held in Everett School District No. 2 of Snohomish County, Washington on the 28th day of May, 1963, at which there shall be submitted to the qualified voters of said district the following propositions, to-wit:

1. Whether or not Everett School District No. 2 of Snohomish County, Washington, shall be authorized to levy in the year 1963 a tax of 10 mills, without regard to any tax limitations provided by law, to secure funds in the estimated amount of \$715,000.00, for the acquiring of sites for, and the construction of new buildings and equipping same, and the modernization of existing buildings, in addition to funds otherwise available for said purpose.
2. Whether or not Everett School District No. 2 of Snohomish County, Washington, shall be authorized to levy in the year 1963 a tax of 10 mills, without regard to any tax limitations provided by law, to secure funds in the estimated amount of \$715,000.00 for the purpose of maintaining, improving, repairing, and rehabilitating existing school buildings, facilities and equipment and maintaining salary schedules and purchasing additional supplies, in addition to funds otherwise available for said purpose.

Be it further resolved: That the Clerk of the Board of Directors of Everett School District No. 2, Snohomish County, Washington, be and he is hereby directed to provide ballots, poll books and tally sheets, to provide polling places and deliver ballots, poll books and tally sheets to the Precinct Election Officers at the polling places; to publish and post notices of said election in the manner and for the time required by law,

BE IT FURTHER RESOLVED that the polling places be open from 8 A.M. to 8 P.M.

BE IT FURTHER RESOLVED that the said district clerk cooperate in every way with the County Auditor as ex officio Supervisor of Elections for Snohomish County, Washington.

BE IT FURTHER RESOLVED that the propositions submitted by this Resolution shall appear upon the ballot in substantially the following form:

PROPOSITION NO. 1

Shall Everett School District No. 2 be authorized to levy in the year 1963 for the district's Building Fund a tax of approximately 10 mills upon all of the taxable property within Everett School District No. 2, Snohomish County, Washington, in excess of the annual tax levy permitted the school district without a vote of the people, such levy to be made in 1963 for collection in 1964, for the purpose of providing \$715,000.00 to pay part of the cost of acquiring new sites and the construction and equipment of new school buildings and modernization of existing buildings, all as more specifically provided in a resolution adopted by the Board of Directors on the 15th day of April, 1963.

Shall Everett School District No. 2 be authorized to levy in the year 1963 for the district's General Fund a tax of approximately 10 mills upon all of the taxable property within Everett School District No. 2, Snohomish County, Washington, in excess of the annual tax levy permitted the school district without a vote of the people, such levy to be made in 1963 for collection in 1964, for the purpose of providing \$715,000.00 to pay part of the cost of maintaining, improving, repairing, and rehabilitating existing school buildings, facilities and equipment and the maintenance of employees' salaries and the purchase of additional supplies, all as more specifically provided in a resolution adopted by the Board of Directors on the 15th day of April, 1963.
