

RESOLUTION NO. 88

WHEREAS, there is an existing need in Everett School District No. 2, Snohomish County, Washington, for kindergarten support, replacement of furniture and equipment in various schools and the general maintenance of school buildings, modernization of the present highschool and the girls' dressing room at North Junior High School, and due to the increase in school population, the building of a six-room addition to the Madison School and the addition of a classroom building to the Everett Junior College, and

WHEREAS, the funds available for such purposes are hopelessly inadequate and it is, therefore, necessary to provide additional funds for such school purposes, and

WHEREAS, plans have heretofore been made for such additions to the Madison School and to the Everett Junior College and for the modernization of the present Everett High School and the girls' dressing room at the North Junior High School and the replacement of furniture and equipment in some of the other schools, and

WHEREAS, by reason of increased costs, moneys sufficient to carry out said plans are not available and the estimated cost of said additional buildings, modernization and the replacement of furniture, and equipment and maintenance of kindergartens, is hereby declared to be, in addition to other funds available for such new buildings, the sum of \$720,000.00.

NOW THEREFORE, BE IT RESOLVED BY the Board of Directors of Everett School District No. 2 of Snohomish County, Washington, that said additional funds be raised as follows:

1. \$360,000.00 by the levy in the year 1960 of a tax of approximately 6 mills, without regard to any tax limitations provided by law, for the purpose of modernizing the old Everett High School and the girls' dressing room in the Everett Junior High School, and the building a six-room addition to the Madison School.
2. \$240,000.00 by the levy in the year 1960 of a tax of approximately 4 mills, without regard to any tax limitations provided by law, for the purpose of kindergarten support, replacing of furniture and equipment in some of the older schools, and general maintenance.
3. \$120,000.00 by the levy in the year 1960 of a tax of approximately 2 mills, without regard to any tax limitations provided by law, for the purpose of providing an additional classroom building for the Everett Junior College.

BE IT FURTHER RESOLVED: That an emergency exists requiring a special election, whereat the voters within said Everett School District No. 2 may ratify or reject the three propositions herein mentioned.

BE IT FURTHER RESOLVED: That a special election shall be held in Everett School District No. 2 of Snohomish County, Washington, on the 19th day of April, 1960, at which there shall be submitted to the qualified voters of said District the following propositions, to-wit:

1. Shall Everett School District No. 2 of Snohomish County, Washington, be authorized to raise the sum of \$360,000.00

by the levy in the year 1960 of a tax of approximately 6 mills, without regard to any tax limitations provided by law, to secure funds in the said amount of \$360,000.00 for the purpose of modernizing the old Everett High School and the girls' dressing room in the North Junior High School, and the building of a six-room addition to the Madison School.

2. Shall Everett School District No. 2 of Snohomish County, Washington, be authorized to raise the sum of \$240,000.00 by the levy in the year 1960 of a tax of approximately 4 mills, without regard to any tax limitations provided by law, to secure funds in the said amount of \$240,000.00 for the purpose of Kindergarten support, replacing of furniture and equipment in some of the older schools, and general maintenance.
3. Shall Everett School District No. 2, of Snohomish County, Washington, be authorized to raise the sum of \$120,000.00 by the levy in the year 1960 of a tax of approximately 2 mills, without regard to any tax limitations provided by law, to secure funds in the said amount of \$120,000.00 for the purpose of providing additional

BE IT FURTHER RESOLVED: That the Clerk of the Board of Directors of Everett School District No. 2, Snohomish County, Washington, be and he is hereby directed to provide ballots, poll books and tally sheets to the Precinct Election Officers at the polling places; to publish and post notices of said election in the manner and for the time required by law.

BE IT FURTHER RESOLVED: That the polling places be open from 8:00 A.M. to 8:00 P.M.

BE IT FURTHER RESOLVED: That the said district clerk cooperate in every way with the Supervisor of Elections for Snohomish County, Washington.

BE IT FURTHER RESOLVED: That the proposition submitted by this Resolution shall appear upon the ballot in substantially the following form:

PROPOSITION NO. 1

LEVY FOR CAPITAL PURPOSES

Shall Everett School District No. 2 be authorized to raise the sum of \$360,000.00 by a levy in the year 1960 of approximately 6 mills, without regard to any tax limitations provided by law, for the purpose of modernizing the Everett High School, the girls' dressing room in the North Junior High School, and the building of a six-room addition to the Madison School, in addition to funds otherwise available for said purpose.

LEVY FOR MAINTENANCE PURPOSES
