MEMORANDUM OF AGREEMENT

Between

Snohomish County Early Childhood Education and Assistance Program/ North Snohomish County Early Head Start and

Edmonds Community College-Snohomish County Head Start/Early Head Start

Purpose and Scope

This purpose of this Memorandum of Agreement (MOA) is to establish policies and working procedures, and enhance collaboration between Snohomish County Early Childhood Education and Assistance Program (ECEAP)/North Snohomish County Early Head Start (Hereafter referred to as "Snohomish County") and Edmonds Community College-Snohomish County Head Start and Early Head Start (hereafter referred to as "EdCC"). Both programs recognize the importance of a strong working relationship and share the common goals of service to income eligible children and families in Snohomish County. This agreement shall be continuously in effect unless changes are recommended at the annual agreement review.

This MOA is not a contract. It confers no rights on the parties or third parties. It does not relieve the parties of any rights, obligations, or duties for their respective programs under local, state, or federal laws, rules, or regulations. This MOA is terminable upon notice by either party.

This MOA provides guidance in the following areas:

- I. Community Assessment needs and strengths of the population in Snohomish County
- II. Service Area Guidelines
- III. Process of referral of families between agencies
- IV. Staff and parent collaboration
- V. Health Advisory Committee
- VI. Commitment to communication and problem resolution

I. Community Assessment

Snohomish County and EdCC programs will strive to coordinate community assessments and updates for services within the geographic areas served by these programs.

II. Service Area Guidelines

Snohomish County and EdCC programs serve children and families in communities located in Snohomish County. In the communities where both Snohomish County and EdCC sites are located, families choose which location they would like to attend. While most geographic areas do not overlap, there are two school districts where both programs operate centers. These school districts are Everett and Mukilteo. It is further acknowledged that both programs recruit throughout all of Snohomish County and will work together to:

- · Provide clarity of message and continuity of information: and
- Recruit families so that children receive early learning services.

Alderwood Early Childhood Center Edmonds School District-Alderwood Early Childhood 2000 200th PI SW Lynnwood, WA 98036 mutually agreed, by April 30th of each year of their planned site locations and slot allocations for the coming service year. The updated list will supplant the current Addendum A for the coming service year and will become a part of this MOA. When expansion opportunities occur, the program contemplating expansion will endeavor to inform the other as expeditiously as possible, thus allowing both programs to strategically plan for inclusion of additional services mitigating possible problems.

III. Process of Referral between Agencies

When Snohomish County is contacted by persons living within the EdCC service area, Snohomish County refers to EdCC. EdCC does the same, referring persons living in Snohomish County service areas to Snohomish County sites. In the communities where both Snohomish County and EdCC are available, families choose which location they would like to attend. When a site location reaches full enrollment, the staff refer families to sites with openings.

IV. Staff and Parent Collaboration

Snohomish County and EdCC will collaborate on staff training and parent training opportunities as appropriate; for example, the Building Foundations That Last language and literacy model is used in ECEAP and Head Start classrooms and BFTL training and technical assistance provided to staff for both agencies.

V. Health Advisory Committee (HAC)

Snohomish County and EdCC have jointly developed the Health Advisory Committee (HAC). The HAC is comprised of community members who represent the medical, dental, nutrition and mental health services. The HAC has been successful in facilitating strategies to address the needs of low income families and specifically for families to access medical and dental healthcare and strengthen nutritional services. The HAC also addresses service delivery implementation issues, concerns and procedures and provides a forum for parent empowerment and leadership skill development. The HAC sends recommendations for new policy or policy changes to the Snohomish County ECEAP and EHS Policy Councils and the EdCC HS/EHS Leadership Council for discussion and approval. Snohomish County and EdCC assign staff who shares leadership in planning and supporting HAC meetings and activities.

VI. Communication and Problem Resolution

Both Snohomish County and EdCC provide services to eligible families and each agency agrees to provide support and assistance for the other where appropriate.

The Snohomish County Early Learning Division Manager and the Edmonds Community College Head Start/Early Head Start Executive Director will communicate regularly to promote positive community relations.
