Reviewing NAEYC's mission statement

Materials Needed

- Handout A-2 Worksheet for Reviewing NAEYC's mission statement

Begin this activity by reading (individually or as a group) the NAEYC Mission statement. Then in pairs or small groups, discuss and/or complete **Handout A-2**. (questions below)

- 1. Who do you believe had a stake in writing NAEYC's mission statement?
- 2. Why do you believe the mission statement for NAEYC also includes a statement of the philosophy and values of the agency?
- 3. Is it necessary for each program to have a mission that also includes philosophy and values? Why or why not?
- 4. Do you think NAEYC's mission statement should be used universally at all early learning centers in the United States?
- 5. How could you, if you were a staff member for an early learning program, show in your daily practice that you support NAEYC's mission statement?

Option 2: Identifying what makes a quality mission statement

Materials Needed

- Handout A-3 "Childcare Center Mission Statements" and Handout A-4,
 "Childcare Center Mission Statements Worksheet"
- Highlight markers

Working in pairs or groups, have students read each of the mission statements on **Handout A-3**. Using highlight markers, highlight parts of the statement that you feel make a high quality program. Then with a partner or alone students will use an assigned mission statement from the handout and discuss and write down five ways they can carry out their programs' mission statement in their daily interactions with children and families. They will complete **Handout A-4** and discuss their findings/reflections with the class.

Option 3: Quality mission statement: high school example

NAEYC's mission is to serve and act on behalf of the needs, rights and well-being of all young children with primary focus on the provision of educational and developmental services and resources (NAEYC Bylaws, Article I., Section 1.1).

Goals

NAEYC expresses its mission in terms of three broad goals:

- 1. Improving professional practice and working conditions in early childhood education.
- 2. Supporting early childhood programs by working to achieve a high-quality system of early childhood education.
- 3. Building a high-performing, inclusive organization of groups and individuals who are committed to promoting excellence in early childhood education for all young children.

Vision Statement

NAEYC's efforts are designed to achieve these ends:

All children have access to a safe and accessible, high quality early childhood education that includes a developmentally appropriate curriculum; knowledgeable and well-trained program staff and educators; and comprehensive services that support their health, nutrition, and social well-being, in an environment that respects and supports diversity.

Worksheet for NAEYC Missions Statement Teacher's Key

Begin this activity by reading (individually or as a group) the NAEYC Mission statement or **Handout A-1.** Then in pairs or small groups, discuss and complete the following:

1. Who do you believe had a stake in writing NAEYC's mission statement?

Anyone who has an interest in the child care center would be involved in writing the Mission Statement, including the owner, director, staff, advisory board, community members, parents, children and staff together.

2. Why do you believe the mission statement for NAEYC also includes a statement of the philosophy and values of the agency?

Mission Statements describe what makes a program unique and explain the overall vision of the program. It describes the goals and makes clear what is important for the program's function.

3. Is it necessary for each program to have a mission that also includes philosophy and values? Why or why not?

Yes. Philosophy and values reflect what the program does on a daily basis as part of their daily practice. Families will pick a child care program based on its Mission Statement and expect it to carry out its stated philosophy and values.

4. Do you think NAEYC's mission statement should be used universally at all early learning centers in the United States? Why or why not?

I believe NAEYC's mission statement should be explained and used as a guide at learning centers but also each center should create its own mission statement with its own values and philosophy.

5. How could you, if you were a staff member for an early learning program, show in your daily practice that you support NAEYC's mission statement?

Staff members in a child care program need to serve and act on the behalf of the needs, rights and well-being of all young children. At the same time they need to provide educational and developmental services and resources for children and families in the child care programs

Our goal is to strengthen the bridge between your work and family life by creating a special place that supports them both.

Mission statement #5

The mission of the Viking Child Care Center is to provide safe, affordable, high quality child care for the Viking Valley community. The Viking Child Care Center provides a cognitively-based program for children ages six weeks to five years. We provide a home-like environment where children are encouraged to develop at their own pace. The Viking staff is committed to the families we serve, providing support and encouragement.

Mission statement #6

At Miss Tami's Family Child Care Center, we provide a home environment that stimulates the whole child.

Mission statement #7

Little Kidz Academy is a family child care home caring for no more than 10 children ranging in ages from 6 weeks to 12 years. This family child care home strives to provide a safe and fun environment for the children attending to learn and grow in. All activities will be developmentally appropriate for the ages and stages that each individual child is in. The program will facilitate the development of the children by observing and implementing a lesson plan that coincides to the development of all the children and their interests.
